All courses are offered only at Saint Louis University School of Medicine.

At the end of each clerkship rotation, students sit for the National Board of Medical Examiners (NBME) Subject examination in that specialty: Family Medicine, Internal MedidNeturology, Obstetrics and Gynecology, Pediatrics, Psychiatry, and Surgery. These are nationally-normed examinations administered to students in most medical schools for the core clerkshipstading is similarly standardized and based on the National Percentile Rank as reported by the NBME. Saint Louis University School of Medicine uses the following criteria for all seven core clerkships:

- x 75th percentile and above = Honors
- x 50th-74th percentile = Near Honors
- x 5th -49th percentile = Pass
- x Below 5th percentile = In Progress for the 1st attempt at the NBME
- x Below 5th percentile = Fail on the 2nd attempt at the NBME
